RE: Lowering The Voting Age Campaign

To Whomever This Concerns:

The Oakland Youth Advisory Commission of the City of Oakland advocates for the inclusion and representation of young people in Oakland politics. The commission believes that with the current political climate, it is essential for the young residents of the City of Oakland to be involved advocates in their community. Either being an advocate in public comment, rallies, community forums, voting, and other forms of civic engagement. We believe it is critical that all residents of the City of Oakland, including young people, should be allowed to vote in regards to their education.

During the past year Oakland Unified School District (OUSD) has proposed to close schools down, cut funding and positions that are vital to the future are vital to the future of the community. If OUSD intends to cultivate creative, motivated, and hard working students, then these irrational and irresponsible budget cuts are not the way to help students. We believe that this should be done when elections for the Board Members of Oakland Unified School District (OUSD) are upcoming. Students and the parents of those students, should be allowed to vote for the OUSD Board Members. Here in California, voters in the City of Berkeley approved a charter amendment, Measure in November 2016, that would allow the City Council to lower the voting age to 16-years old for elections for school director. We believe that the City of Oakland should follow this example and provide a platform for civic engagement for Oakland youth.

We the Oakland Youth Advisory Commission, hereby endorse All City Council's effort to lower the voting age for school district board elections. We believe that young people know what's best for young people and as a unified voice, with the support of adult allies, we can and will be heard. We believe that participating in civic engagement at the local level is one of the surest pathways to influence positive lasting change in our community and we are committed to identifying and providing opportunities for youth to better understand and engage in local government.
