

COVID-19 Safety Protocols- OPRYD Indoor Rentals

RENTAL CONTRACT HOLDERS AND/OR DESIGNEE WILL BE RESPONSIBLE FOR SCREENING ALL EVENT ATTENDEES ON DAY/s OF EVENT/PROGRAM.

To ensure the continued safety of employees and visitors in Oakland Parks, Recreation, & Youth Development Rental/Enterprise Facilities, the following policies shall be followed for all indoor rental spaces.

ENTRY REQUIREMENTS

<u>Before entering a City of Oakland OPRYD Rental Facility, city staff, patrons, and rental contract holders</u>
<u>& their guests must adhere to the following:</u>

- 1. Wear a mask at all times while inside facility regardless of vaccination status.
- 2. Complete a COVID-19 Safety Health Screening
- 3. Provide verification of vaccination status; effective February 1, 2022, proof of vaccination will be required for people 12 years and older to enter the following indoor public locations in Oakland Verification of Vaccination Order
- 4. For people 18 years and older, the vaccination card must be cross-checked with the individual's photo ID. Patrons entitled to a qualified medical exemption must provide verification of their exemption and proof of a recent negative COVID-19 test.

Vaccination Proof includes:

 Original, copy or picture of your vaccination card from the CDC, a healthcare provider, or a government agency or a digital COVID-19 vaccine record issued by the State of California

- b. Valid Photo ID cross checked (ages 18 and over)
- 5. You may be exempt from these requirements if you are entitled to a reasonable accommodation for a medical condition. To qualify, you will need to show verification of medical exemption, proof of a recent negative COVID-19 test, and photo identification.

COVID-19 Safety Health Screening- Before Entering

Rental Contract Holder/Designee will be asked to assess their health and required to assess their attendee's health by answering the following (below) questions before entering a city facility: A designated screening space will be provided.

- In the past 14 days, have you had a positive COVID-19 test?
- Within the past 14 days, have you been in close contact with someone currently sick with, suspected or confirmed, COVID-19?
- In the past 24 hours, have you experienced any of these symptoms (that cannot be attributed to another health condition)?
 - Fever (100.4 F or higher), Chills, Cough, Fatigue, Muscle or body aches, Headache, New loss of taste or smell, Sore throat, Congestion or runny nose, nausea or vomiting, Shortness of breath or difficulty breathing.

If a <u>visitor answers YES</u> to any of the screening questions, then:

Visitor will be denied entry. The visitor must not return until required isolation time or as otherwise directed by their medical provider.

Site Staff

Site Staff will provide a table at entrance of facility, to support all screening requirements. Site staff will be on site to ensure proper screening, answer any questions and remind guest of safety measures, such as following signage, practicing physical distancing, and wearing a mask while in city facilities.

Informational Safety and Directional Signage

Directional and informational safety signage will be in place in identified city facilities to reinforce the current public health guidance to employees and visitors. <u>Multi-lingual Poster</u>

Reduced Building Entries

The number of entries in some buildings has been reduced to ensure that employees and visitors are routed through designated health screening/proof of vaccination stations. Signage is in place at closed and open entryways, and routes and entries are ADA accessible.

Capacity Threshold

Each OPRYD rental facility is unique in its square footage and ventilation capacity. Rental threshold will be dependent onsite coordinator; factors may include type of event and current county guidelines.

Indoor Ventilation

Staff and Rental Contractor Holder and/or Designee shall increase ventilation of indoor spaces (i.e., open all windows and doors to increase natural air flow), following current CDPH (California Department of Public Health) and CalOSHA guidance. CDC Ventilation

Communications

Rental Contract Holders (organizers) and city staff are responsible for communicating city guidelines, mandates, and policies to all guest, communications shall be present on event/program advertisements.
